Report on the Minutes of the meeting of the Members of the Governing Body held on 16th August, 2017, at 11.45 a.m., in the Conference Hall.

- The Proceedings of the meeting had the divine sanction of getting commenced with the Quirath rendered, in its spiritual elegance, by Dr. K.R. Mohamed Sufiyan, Asst. Professor in Commerce.
- The Welcome Address, ornamented with the verbal gems of fraternal reverence, presented by respected Principal, Dr. S.A. Sajid, had been a sprightly cascade of cordial intimacy and coveted courtesy.
- 3. The effulgent canvas of discussion then flashed its attention towards the Academic Journey of the college during 2016-2017, officially branded as the Progress Report of the college, which had the blessed fortune of getting flagged of by Dr. S.A. Sajid who unlocked the treasure of Awards and Aspirations of Staff and Students that culminated in heralding yet another Year of outstanding achievements in Academics, Research avenues and in the realms of Sports & Games. Major Dr. Syed Shahabuddeen former Principal of Islamiah College, Vaniyambadi, had been graceful enough in appreciating the noble gesture of the college in presenting the Progress Report for the kind notice of the Governing Body where as many of the colleges which he had the distinguished honour of visiting as one of the Officials connected with Autonomy had simply ignored the presentation or submission of such Reports. His words of praise had been like gentle showers in Spring.
- 4. The august Assembly witnessed one more Presentation that comprised the Minutes of the Fourth Meeting of the Academic Council so notably executed by Dr. H. Munavar Jan, Head, P.G. & Research Dept. of History who gave a broad survey of changes incorporated in the Curricula restructured for the Votaries of Arts, Science & Commerce of the U.G. and P. G. Courses.

- 5. The dais of discussion yielded place to the presentation of the Minutes of the Fourth Meeting of the Finance Committee which had the blessed fortune of getting expression in the voice of the Principal, Dr. S.A. Sajid, who putforth necessary details, on the lines of a flood of information, that went straight to the ardent notice of the exemplary Members of the Governing Body.
- 6. The nerve centre of discussion, Exam Results, took on its wheels with Dr. A. Abdul Rahuman, Controller of Examinations, furnishing the visiting Dignitaries with ample details pertaining to the results of the V & VI End Semester Examinations conducted in November, 2016 and April, 2017, which for he sought the ratification and which were promptly ratified by the Governing Body. The Controller explained that the strenuous efforts of Staff and Students and their committed devotion towards CIA Tests I & II had been the academic elements that amplified the spectrum of results in their manifested but meaningful excellence.
- 7. A detailed and a full length discussion on Examinations continued like the chain reaction with the briefing up of the Exam Reforms that were planned and executed. The Controller of Examinations presented in elaborate dimensions the Reforms in Exams that were initiated to help students to be the beneficiaries and to fulfil the goal and as the purpose of education. The changes adopted to make examinations more transparent and much more justified as the fruit of Examinations should be delicious to students and sweeter to the Toppers.

CIA Tests I and II pertaining to Semester Examinations of November, 2016, were conducted from 2nd September, 2016 to 9th September, 2016 and from 22nd October, 2016 to 1st March 2016, respectively. The End Semester Exams were held as per the Schedule from 7th November, 2016 to 23rd November, 2016. Valuation of answer – scripts commenced on 2nd December, 2016 and the Results were published on 9th December 2016.




Similarly, CIA Tests I and II belonging to the Semester Examinations of April, 2017, were scheduled from 31st January, 2017, to 9th February, 2017 and 13th March, 2017 to 20th March, 2017, respectively. The End Semester Exams were from 10th April, 2017 to 28th April, 2017. Valuation of answer-scripts that began on 24th April, 2017 came to an end with the last script valued on 3rd May, 2017. Results were published on 9th May, 2017 with the good offices of hon'ble General Secretary of MMES, Alijanab S. Ziauddeen Ahmed Saheb.

The Instant Exam for Students of Final Year Classes with one Arrear Paper was held on 10th July, 2017 and Results were published on 12th July, 2017.

Likewise, the Viva-Voce Exam for the Scholars of M.Phil., Programmes were organized on 9th September, 2016 and 1st, 2nd and 5th December, 2016 pertaining to the End Semester Examinations of September, 2016. Proposals for Provisional Certificates related to 27 Full-Time and 4 Part-Time M.Phil., Scholars were submitted to Thiruvalluvar University and the Semester Exams for Part-Time M.Phil., Scholars were held from 20th August, 2016 to 27th August, 2016.

The End Semester Examinations (February, 2017) for M.Phil., Scholars were conducted from 18th February, 2017 to 25th February, 2017 and the Results were published on 27th March, 2017.


8. The next event in the Proceedings of the meeting had been a plan-oriented schedule for the sound future of the college. The Future Plans of the college were presented by Dr. K. Anver Basha, Asst. Head, P.G. and Research Dept. of Chemistry, that would light the lamps of academic excellence, research exemplaries, career marvels and Awards & Rewards in Sports & Games and in other Co-Curricular and Extra-Curricular spheres. The plans would be largely student- oriented to pave avenues for their further progress and to acquire cyber- skills, communication skills, soft skills, hard skills and life skills.



- 9. The next phase of discussion switched on the Presentation of the Minutes of the previous meeting of the Governing Body. Dr. K.Anver Basha, initiated the Minutes with due explanation to the high expectations of the Members present. After proper initiation, he sought the Governing Body's approval of the Minutes. The Minutes were given a green signal by the Members in the light of their thematic relevance and topical significance.
- 10. Major Dr. Syed Shahabuddeen, as an important segment of the meeting, enquired about students indulging in Malpractice and expressed his desire to know the quantum of punishment meted out to such students. Dr.S.A.Sajid said that the college had chalked out a scheme to abolish such practices on the campus. Parents of such students would be asked to submit a signed Declaration that they would be careful in making their wards give up such practices. This concession would be extended to erring students only once. If the academic sin of malpractising was repeated, such students would be debarred from taking up the whole lot of that particular Semester Exam.
- 11. The scene of discussion shifted again to the College Report with Major Dr. Syed Shahabuddeen suggesting the presentation of proper and prompt action taken by the college as presented in the Report. He also came out with an advice to change the caption, 'Agenda' into 'Proceedings' or 'Programme Schedule' as 'Agenda' would mean the items in their proper order for discussion. He felt that not much or more would be discussed at the meeting of the Governing Body. And hence, he insisted on the change.
- 12. The need based learning' assumed a greater significance with Dr.Bhagawan Singh Chaudhary, hon'ble Registrar, Chaudhary Bansilal University, Biwani, proposing its implementation on the campus to strengthen students' ability and qualification to a matching career. He wished that the 'Outreach Programmes', planned by the college, should be shouldered by the Programmers in the Computer Lab and NSS Programme Officers and Volunteers for the benefit of the society. His yet another

suggestion to popularize proper use of Computers and Mobile Phones should be one of the chief concerns of the college had been well endorsed by the Members present at the meeting. Major Dr. Syed Shahabuddeen, while welcoming the suggestion praised it as an academic treasure for students and insisted on its dire need in the shifting educational and career-oriented scenario. He hoped that the college would link need-based learning with all other need-based Programmes existing in the college. In all eagerness, he gave ventilation to his sincere wish that the massive research work going on in the college should be appreciated and the appreciation received from so many Scientific Bodies should be recognized to sustain research on the campus and for its growth in the forthcoming years.

13. The focus of attention then switched over to the mechanism involved in awarding Grace Marks to help deserving students to secure the Passing Minimum. To a question similar to this posed by Dr.Bhagawan Singh, the Controller of Examinations presented full-fledged details in helping students to secure a Pass under Moderation. Dr. Singh also put forth a suggestion that the college should create avenues to provide quality study material to students free of cost and also should impart necessary skills to improve students' prospects of securing a decent While appreciating the solid achievements of the college, Dr.Singh suggested that the college should evince more interest in developing communication skills of students. Dr.S.A.Sajid explained to the august Body that the college was catering ably to most of the educational and career needs of students by channelizing avenues for imparting necessary skills to equip students with the academic potential to fair well in such exercises that would fetch them a decent and dignified career. He cited an example by disclosing the fact that students were trained in Communication Skills by the Dept. of English. The Skill-Based and Non-Major Papers were taught in all sincerity to streamline and strengthen students' academic armour to cope with the expectations. He brought to light that the Dept. of Urdu was conducting Urdu-Oriented Programmes for the sake of Non-Urdu knowing students.





- 14. Major Dr. Syed Shahabuddeen opined that the college having progressed a lot over the years and having obtained Autonomy should establish a Skill Development Centre to expose students to various useful skills to develop their personality, academic wise and life wise. He also suggested that the college should apply to the Government requesting for 100% Grant to harness on the campus a Skill Development Centre fitted with the latest and sophisticated instruments to boost the skills in the larger and the best interest of students. Dr.S.A.Sajid expressed his grateful thanks to him for his timely suggestion that would enhance to image of the college, still more.
- 15. Dr.Bhagawan Singh Chaudhary was all praise for the college and distinguished Management for respecting education as not only the wealth of the society but also as an asset of the country. He showered rich encomiums on the Institution for spreading the ennobled cause of higher education with no eye focused on Commercial gains.
- 16. The lengthy presentations and discussions came to end with a Vote of Thanks proposed so warmly and so fraternally by Dr.H.Munavar Jan.

Minutes of the Meeting of the 4th Governing Body held on 04.05.2018, at 11.30., a.m. in the Conference Hall.

The scheduled Proceedings were flagged off by a spiritual Incantation rendered by Dr. K.R. Mohamed Sufiyan, Asst. Professor in Commerce.

The Celestial fragrance of divine commencement paved way for a hearty Welcome Addresspresented so cordially by the Principal, Dr. S.A. Sajid.

After the initial prayer and a warm Welcoming, the academic scene shifted to the Minutes of the 3rd Governing Body Meeting held on 16.08.2017. The Principal sought the approval of the solid Minutes which had the privilege of getting approved by the Council.

The official approval yielded place to the Presentation of the Progress Report on the activities of the college during 2017-18 that were gilded with the hopes of aspirations and the solid pleasure of achievements. The Academic Journey had been a Visa to the realms of Recognitions, Awards and Rewards.

Principal, Dr.S.A.Sajid had the goodwill of presenting the Minutes of the Fifth Meeting of the Academic Council on 03.04.2018 which were given a patient listening by the Council.

Similarly, the Principal gave a detailed account of the 5th Meeting of the Finance Committee on 05.04.2018 by presenting the Minutes to the august notice of the Members.

The CIA Tests I & II related to End Semester Examinations in November, 2017, were organized from 06.09.2017 to 12.09.2017 and from 23.10.2017 to 30.10.2017, respectively. As per the worked out Schedule, the End Semester

Examinations were conducted from 07.11.2017 to 22.11.2017 in all earnestness and with all the seriousness that the Examinations required. As the regular academic routine, the Arrear Examinations were steered on 7 Saturdays. These Examinations were held on 5th and 19th and 26th August; 16th and 23rd September 2017 and 7th and 21st October, 2017. The Central Valuation had been effectuated from 10.11.2017 to 28.11.2017.

A total number of 42 Provisionals that included 38 U.G. and 4 P.G.

Provisionals were submitted to the University. The Viva-Voce Exam for M.Phil.,

Scholars was conducted on 24th October,2017 and 03.11.2017 and the Results

were published on 30th November, 2017. Provisionals of 31 Full-time Scholars and

9 Part-Time Scholars were submitted to Thiruvalluvar University. The Theory

Exams for the M.Phil., Part-Time were held from 1st September, 2017 to 11th

September, 2017. Results pertaining to these Exams were published on line on 9th

October, 2017. Similarly, the M.Phil., Semester Examinations were conducted from

17th February,2018 to 24th February,2018, Results were published on 28th March,

2018.

The CIA Test I related to End Semester Examinations in April, 2018, had been conducted from 29th January, 2018, to 6th February, 2018. Similarly, the CIA Test II had seen the light of the day from 5th March, 2018 to 12th March, 2018. The End Semester Examinations were held from 11th April, 2018 to 26th April, 2018.

To help students to lessen the academic burden of Arrears, Saturdays were set apart for the conduct of Arrear Examinations. As per the Schedule these Examinations were conducted on 10th, 17th, and 24th of February, 2018; 3rd, 17th and 24thMarch; 7th and 9th April, 2018. And thus, Arrear Examinations were completed by conducting them on 8 Saturdays. Answer-Scripts pertaining to the End Semester Examinations were valued by External Examiners at the Valuation Centre on the campus from 17thApril to 30thApril, 2018. To help Students who were just below

the Passing Minimum, as many as 320 students were given pass by awarding marginal marks. In adherence with the guidelines formulated in earlier Academic Council Meetings, the Results were published on 4th May, i.e., on the 7th day from the last Semester Exam. As provision was made for students to apply for a Photocopy of their answer-scripts to maintain transparency in the Evaluation Process, a total number of 19 Students had applied for the photocopy. Likewise, as the college had provided the academic facility for students to apply for Revaluation of their answer-scripts, a sizeable number of 188 students had applied for revolution of whom 53 students secured the Passing Minimum and even above. 44 students who indulged in Malpractice were awarded no mark. A total number of 1994 U.G. students appeared for the End Semester Examinations and 710 students cleared all the Papers registering a Pass Percentage of 35.62. As many as 144 students took the P.G. Exams and 99 Students cleared all the Papers with a Pass Percentage of 68.66. The Controller's Office dispatched the Provisionals of 286 U.G. Students and 78 P.G. Students accounting for a total of 364 students.

To help students falling just below the Passing Minimum, a sizeable number of 259 Students were given Moderation Marks. The Results pertaining to these Examinations were published on 30th November, 2017 i.e. with a gap of just eight days from the last examination on 22ndNovember, 2018. Thirty-Five students applied for the Photocopy of their answer-scripts and 62 students had the privilege of applying for Revaluation. Thirty-One students had the misfortune of indulging in malpractice who were not awarded any mark. As an academic punishment, they were given 'Zero'. A total number of 2043 students appeared for the U.G. End Semester Examinations and 868 students cleared all the Papers registering the Pass Percentage of 36.49.

As many as 159 P.G. Students took the Exam and 91 students cleared all the Papers accounting for a Pass Percentage of 65.36.

The Minutes of the Meetings of the Committees heralded the entry of

Examination Reforms. The Controller of Examinations, Dr.A.Abdul Rahuman,

presented the Reforms made in improving the mechanism of Examinations in the

larger interests of students. He also sought the ratification and approval of the

Results of Semester Examinations published in November, 2017. The Council had


the pleasure of ratifying and approving the Results hailing them as the fruits of

students' hard labour in the land of Academics.


Major Dr. Syed Shahabuddeen, former Principal of Islamiah Women's College
