Eligibility:

- i. Candidates who have failed in **two papers only** are eligible for Re-valuation.
- ii. If the candidate has passed in all the papers, then also eligible for any two papers only.

Last Date:

- i. The last date for submitting PG / UG Re-valuation application is on or before **06.06.2023**
- ii. Applications received after the due date, even the fees have been paid in stipulated time, will be rejected summarily.

Other important instructions:

- i. Request for Re-valuation should be made in this prescribed form only. No other formats shall be accepted.
- ii. The application should be duly filled in by the candidate only, and the same should bear the signatures of the concern Head of the Department and the Principal.
- iii. Applications without signature and seal of the Principal will be rejected summarily.
- iv. Incomplete / defective applications without necessary fees shall be rejected.
- v. There is no provision for Re-valuation of practical examination papers.
- vi. Re-valuation applications should be addressed through the concern **Head of the Department.**
- vii. Re-valuation result will be sent only to the Principal of the college.
- viii. The candidate may apply to register for the subject, in which Re-valuation is sought, in the next examinations within the stipulated time without waiting for the results of the revaluation.
